Youth in Tourism

Eligibility: A Ni-Vanuatu youth between 12-30 years who owns and operates a tourism business in Vanuatu and is registered as an active youth through the Vanuatu National Youth Council.

Entry Instructions

This category recognizes the contribution and commitment of youth individuals engaged in the Tourism Industry. The award is an acknowledgement of exceptionally dedicated individuals who go beyond their typical job descriptions to support their colleagues and industry, and to enhance the visitor experience. Nominations may be given (where the person doing the entry is not the person being nominated).

SUBMISSION GUIDELINES

Please take note of the following:

- The two sections of the written submission must be minimum one A4 page and maximum two A4 pages each
- o Submissions should be no longer than 4 A4 pages in total
- Submissions may be handwritten or typed but must be legible and using text of reasonable size
- All information within these limits will be considered when awarding points and judges will be instructed to disregard any information supplied that exceeds the section or attachment limits
- Submissions may include up to four attachments these must be clearly identified and listed on the checklist above.
- o Submissions can be in the 3 official languages (Bislama, English or French)

Total score for each Awards entry is **30 points**, 20 of which come from the written submission. The total points are awarded against three sections, as follows:

- An overview of the nominee (5 points)
- Personal service and contribution to the industry (15 points)
- Personal interview (finalists only) (10 points)

TIPS FROM THE JUDGES

Consider the content and size of the Attachments carefully – they should be connected to the questions and their relevance referenced in your answer. Examples of suitable attachments could be a CV, copies of Awards/Accreditations received (do NOT attach originals as documents cannot be returned), customer feedback naming the nominee, photographs of nominee performing in their role.

Judges are looking for concise (to the point) answers that clearly respond to the question asked. Ensure you include key information you want the Judges to know into the section against which it will score points and not in sections where it is less relevant.





JUDGING CRITERIA

Section 1: Overview of the Nominee (5 points)

- a) Correct nominee details and name of person nominating the candidate, if applicable (1 point)
- b) Number of years the nominee has been working in the tourism industry (1 point)
- c) Photos, references or other evidence of tourism business (3 points)

Section 2: Personal Service and Contribution to the Industry (15 points)

- a) Overview of current business and duties (2 points)
- b) Details of major achievements including accreditations and awards (3 points)
- c) Contribution to the Vanuatu tourism industry as a whole, in particular in the areas of promoting sustainable environmental and/or cultural practices (10 points)

TIPS FROM THE JUDGES

Part a) Consider how the applicant <u>regularly</u> exceeds their job description, for example by taking on additional responsibilities, supporting other team members, or providing an extra level of service to customers or management beyond what the business expects of all employees in their role.

Part b) Consider how the applicant engages with the broader tourism industry and local communities. Have they initiated any practices or activities that stand out in terms of environmental protection or promoting local culture or transfer of skills?
